- 2. Bid Date: February 15, 2024, 2:00pm at the office of LPS Facilities and Maintenance, 800 South 24th Street, Lincoln, NE 68510.
- 3. Bid Proposal Form is in the Specifications & Project Manual.
- 4. Each bid proposal must be accompanied by a Certified Check or Bid Bond payable to Lincoln Public Schools in the amount of 5% of the base bid proposal.
- 5. Performance Bond and Labor and Materials Payment Bond shall be provided in the total amount of the contract.
- 6. Do not include sales tax in your bid. Lincoln Public Schools is tax-exempt.
- 7. Project will be constructed under a single prime contract per Agreement in the specs.
- 8. Building Permit process is by the Engineer. Contractors will be required to obtain any other special permits.

Overview of Project

The project consists of the replacement of the existing swimming pool dehumidification unit at Northeast High School with a new unit and remote compressor section. Corresponding HVAC, piping, electrical and miscellaneous general construction trades will also be required.

Site Use

- 1. Contractor use of site will be limited to construction area identified on the drawings only. The Owner will be occupying the site during construction.
- 2. Equipment may be stored in the building at locations approved by the Owner.
- 3. Provide temporary toilets, wash facilities, and drinking water for use of construction personnel. Use of Owner's existing toilet facilities shall not be permitted.
- 4. Provide adequate floor and wall protection systems during demolition and construction. Provide adequate means of dust control throughout the construction spaces.

Schedule

- 1. Contractors may access site once all appropriate contract paperwork is completed. Work may commence in the upper mechanical rooms as long as it does not affect school operations.
- 2. Anticipated start date is June 3, 2024.
- 3. Timing of work is critical to complete the project by October 1, 2024.
