MISCELLANEOUS CLARIFICATIONS

BUILDING SOIL PREPARATION CLARIFICATION PER SOIL REPORT AND CIVIL ENGINEER:

- Overall site soil should not be over excavated or removed.
- Top 24 inches of soil should be reworked and compacted as recommended in the Soils Report "Earthwork Site Preparation" section.
- If new soil material is added it could be any of the ones listed in the "Fill Material Types" table on page 6 of the Soils Report, and is to be compacted to the same level as the soil being reworked.
- For soil under and around footings and foundations, the Soils Report paragraph on page 10 to 12 shall be followed with either "lean Concrete backfill" or "Over-excavation / Backfill" with compacted structural fill being acceptable as long as is compacted as recommended to the 98% of maximum compaction.
