Plans: Replace Drawings sheets 1-4 with attached.


Item 1 - Revised extents of flooring work in areas called out on plans.

Item 4 - All carpet to tile transitions are to be mechanically fastened metal transitions. All transitions at heat pump closets to be rubber to match wall base.






