5. If you recognize any of our patients or obtain access to confidential information during your visit, we ask that you please respect their right to privacy by not sharing this information with others.

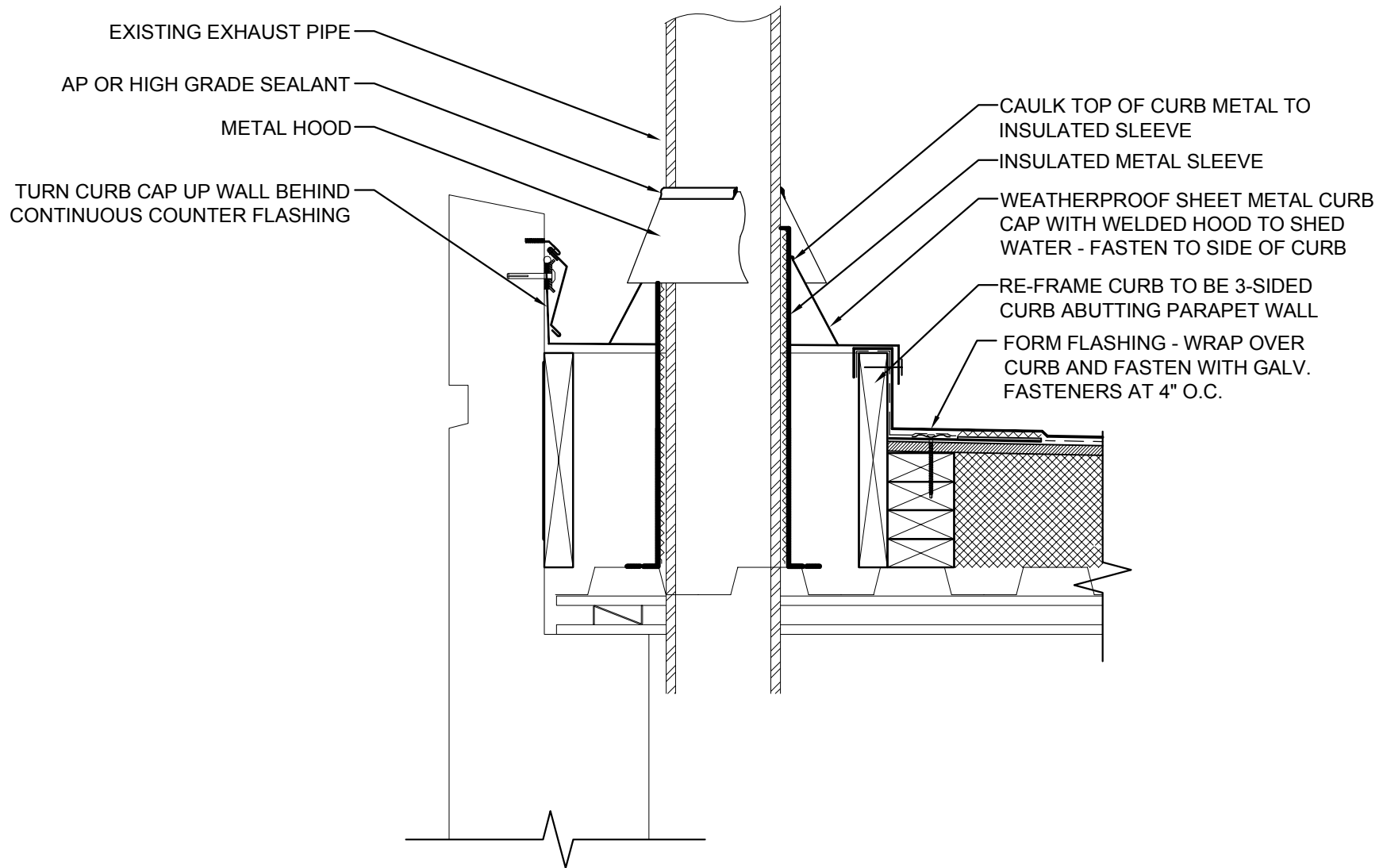
