The Project Manual and Drawings shall be modified or revised as herein described. Where at variance with the original work, this Addendum shall have precedence.

This Addendum modifies the original Bidding Documents. The Bidder must acknowledge receipt of this Addendum in the space provided on the Proposal Form. Failure to do so may subject bidder to disqualification.

ADDENDA ITEMS:

AD1.1. Clarification: All existing downspouts shall be replaced to extents currently in place, unless noted otherwise.

AD1.2. When replacing downspout at west end of the north elevation, Contractor shall add a 4' horizontal extension to the new downspout.

AD1.3. Revision: Base bid price shall not include replacement of any existing roof sheathing deemed deteriorated. Contractor shall provide unit price for material and labor to replace any/all deteriorated existing 3/4" plywood roof sheathing, if deemed necessary during demolition, by Contractor and Owner. Refer to the attached amended Bid Form.

AD1.4. Revision: NDOR project number is AFE I-690 in lieu of AFE I-729 shown on drawings.

AD1.5. Revision to specifications section 07 61 03; 2.3B; underlayment shall be 45 mil., Winterguard HT in lieu of product specified.
