This Addendum is issued to all known plan holders before receipt of proposals.

The following shall be included with, and considered a part of, the original contract documents to the same extent as if they were included therein, for the construction of the above mentioned project. The Project Manual and Drawings shall be modified or revised as herein described. Where at variance with the original work, this Addendum shall have precedence.

This Addendum modifies the original Bidding Documents. The Bidder must acknowledge receipt of this Addendum in the space provided on the Proposal Form. Failure to do so may subject bidder to disqualification.

ARCHITECTURAL ADDENDA ITEMS:

AD2.1. Unit Price #1 Bid: The Contractor shall provide a Unit Price, in Cost per Lineal Foot (\$/L.F.), for installation of the well depth beyond that shown on the Drawings.

AD2.2. Updated Bid Form: The Contractor shall use the attached updated Bid Form which includes a line item for Unit Price #1.

AD2.3. Specification Section 08 41 13 Alum. Framed Entrances - Correction: There are no Flushline Doors in the project.

AD2.4. Drawing Sheets A301 – A301 – Correction: The exterior furring stud walls do not continue above the mezzanine as shown on the detail sections – the exterior walls on the mezzanine are only the metal panels on the metal building girts per the wall type schedule.

AD2.5. Drawing Sheet A100 – Correction – Wall Type 7 is listed as 1-hour rated, however the only required rated walls are those shown on Sheet G101.

CIVIL ADDENDA ITEMS:

AD2.6. Clarification - The 2" sanitary force main pipe shall be PVC SDR 21 Class 200.

AD2.7. Sheet C105 – Correction: The reference to Utility Note 2.4 should be note 24.

AD2.8. Drawing Clarification: The Contractor shall only be responsible for all grading in the area shaded as shown on Sheet C103. The Contractor will coordinate timing of grading by Owner for all other areas.
